# FREELAND WATER and SEWER DISTRICT ISLAND COUNTY WASHINGTON Minutes of Regular Meeting – February 8th, 2023

#### 1. CALL TO ORDER

Chad called the meeting to order at 10:04 a.m.

2. <u>AGENDA</u> - Commissioner Hanson moved, Commissioner Randall seconded, approval of the agenda after addition of a discussion of the Pleasant View main replacement project. *Agenda approved unanimously* 

## 3. <u>APPROVAL OF MINUTES</u> –

Commissioner Hansen moved, Commissioner Hansen seconded, approval of the minutes of the January 11<sup>th</sup>, meeting. *Motion passed unanimously* 

- **COMMISSIONERS REPORTS** Commissioner Gladhart participated in the first meeting of the Port of South Whidbey scheme development process. Commissioner Gladhart felt the purpose of the meeting was ensure other jurisdictions were aware of their planning process, and he does not anticipate attending future meetings.
- 5. <u>AUDIENCE PARTICIPATION</u> None
- 6. **PROJECT REPORTS** -
  - **6.1 Harbor Hills Well 3B** Roger Kuykendall is still waiting for a scope of work from Robinson Noble.
  - **6.2** Freeland New Well 5– Roger Kuykendall reported by prior email that PPG was not ready to present its report yet.

## 7. <u>UNFINISHD BUSINESS</u> –

- 7.1 Water rates Commissioner Hansen reminded the Board of the need to update connection charges with new inflation rates, 2022 capital projects, and anticipated capital projects. Commissioner Hansen moved, Commissioner Gladhart seconded, that we update the base rate with each April billing so we have both the ENR and Seattle CPI inflation rates and can apply it to first quarter water bills. Terri will identify 2022 capital projects, Andy will update anticipated capital projects, and Commissioner Hansen will incorporate this into the connection charge worksheet prior to the March meeting.
- **7.2 Regulations update** The Board met January 17<sup>th</sup> and discussed definitions in the existing regulations. Another workshop scheduled for February 22nd, 10 a.m. to discuss sections 2-5 of the existing regulations.

- **7.3 Pleasant View Drive main replacement** Andy Campbell reported that the main and hydrants are installed but connections have not been completed. The Board agreed the road needs to be repaired after the project is completed.
- **7.4** Commissioner Laptops Commissioner Randall said Apple is coming out with a new line of laptops. He will evaluate options to purchase discontinued models.

## 8. <u>NEW BUSINESS</u> –

8.1 Leak Relief – Terri reported that account 71346 requested a leak relief adjustment but has not provided proof of repair. Commissioner Hansen moved, Commission Gladhart seconded, approval of the \$92.85 adjustment pending receipt of proof of repair or a letter confirming the repair was made.
