- **5.2 Sunnyview Farm** Roger said Andy now has the parts list needed for the connection. Terri reported Andy has been communicating with vendors. The district will install meters for existing connections when SVF is connected to Freeland. New connections will be required to pay a connection fee.
- **5.3 Fish Forest Pump Station** Roger had recommended that Andy contact Pump Dynamics (Washougal) provided pump skid; it may be possible to replace VFD with newer model that won't have the same problems. Andy is talking with a VFD expert to see if a filter can resolve current electrical problems.

- **6.1 Cell Tower** A completed survey of the cell tower site has been sent to Verizon. Verizon is waiting for a stamped survey.
- **6.2 General Facility Charge Assessment** Lew has revised the calculations to allow for a variable inflation rate. Terri will assemble a complete memorandum with appendices.
